

Various Security Forces and Agencies and Their Mandate

Various Security Forces and Agencies and Their Mandate is a topic in UPSC Civil Services Mains GS Paper 3. Splitting up the keywords – we get two areas to focus – (1) **Various Security Forces and Agencies** (2) **Their Mandate** – ie. the authority to carry out a policy or action. There are external and internal threats to security of India and different specialized forces of India deal with these threats. The external threats are handled often by the Armed Forces under the Ministry of Defense, while internal threats are managed by the Ministry of Home Affairs.

Security Forces

1. Indian Armed Force
2. Central Armed Police Force

Security Forces Dealing with External Threats

The **defense forces** (Indian Armed Force) are the primary force responsible for security of the country, and they come under the authority of Ministry of Defense. **Central Armed Police Force (CAPF)** too aid in combating external threats (they mainly manage internal security issues), but are managed by Ministry of Home Affairs.

Indian Armed Force

The defense forces are divided into four sub-heads.

1. Indian Army Personnel.
2. Indian Air Force Personnel.
3. Indian Navy Personnel.
4. *Indian Coast Guard Personnel.*

Security Forces Dealing with Internal Threats

There are many divisions of Central Armed Police Force, which deal with internal threats.



Central Armed Police Force (CAPF)

1. *Assam Rifles (AR)*
2. Border Security Force (BSF)
3. Central Industrial Security Force (CISF)
4. Central Reserve Police Force (CRPF)
5. Indo Tibetan Border Police (ITBP)
6. National Security Guard (NSG)
7. Sashastra Seema Bal (SSB)
